In order to prepare for your visit, here is a list of things (non-exhaustive) that your child will need for our activities.

**All activities:**

- Backpack with water bottle, sunscreen, sunglasses, cap, small snack (pic-nic for 9/13 years)
- suitable sportswear

It will be necessary to add for the following activities:

**Water activity (canyoning, rafting, Wibit, Paddle)**

- swimsuit, towel, water shoes or old sneakers, spare shoes.

**For aquatic activities a patent of 25 m minimum is required (to appreciate that the child knows how to swim and can be immersed)**

**mototrial**

- gloves, full-face helmet, kneepad type protections (if you have them, otherwise they will be loaned)
- long pants and long sleeves

**Commando course**

- shoes with trail type crampons, spare shoe

**The activities are likely to be modified depending on the weather and the conditions of practice on the part of our service providers. We will offer you an alternative with other activities.**

**Cancellations conditions :**

The activities require a minimum of 4 pupils to go ahead. Should it not be the case we will try our best to give you alternative solutions

**Cancellation earlier than 7 days before the start of the service:**

## **Prices / Registration / Payment**

The prices stated comprise the teaching service dispensed by an E.S.F. instructor, excluding any other service (insurance, ski lifts, accommodation, etc.), except in specific cases. Consequently, pupils shall, before the activity time, be in possession of a pass to access the ski lifts and, at the pupil's discretion, insurance to cover themselves against the inherent risks of practising sport in a mountain environment (civil liability, mountain rescue, etc.).

## **Terms of registration and payment**

Registration takes place by sending a booking form accompanied by the full payment by cheque, bank card, etc., to the E.S.F.

The E.S.F. solely guarantees the availability of the lessons that are proposed at the time when the contract is concluded.

This payment signals the conclusion of the contract.

## **Schedule**

The participants will be welcomed at the ESF office (662 avenue de Joux plane, 74410 MORZINE) from 08h30 to 09h00

These schedules may change depending on the demands for the activities. Any changes will be specified in the program of the week.

The ESF provides children cloakrooms to be able to change and put their clothes and personal belongings.

## **Service**

All aquatic activities (rafting, canyoning, hydrospeed, etc.) and mountain activities (climbing, via ferrata, mountain biking, motocross, paragliding, etc.) are supervised by state-certified external service providers.

The groups are followed all week by a qualified and qualified animator.

## **Conditions of Acceptance**

- be registered with the ESF and have made the payment before the departure for the activity
- have no medical contraindications for sports practice (provide a medical certificate less than 6 months old)
- have completed and given the registration form before departure for the activity
- have appropriate clothing and equipment adapted to the activities
- for aquatic activities a patent of 25 m minimum is required (to appreciate that the child knows how to swim and can be immersed)

## **In case of bad weather**

In case of bad weather, the ESF will modulate the program in order to carry out all the promised activities. In this case, the team will offer activities related to the discovery of fauna, flora, mountains...

Bring pool clothes and swimming suits if the weather conditions are not good.

## **Health / Accidents**

- No observations will be taken into account if it is not notified on the registration form.
- The ESF is authorized to take **all the necessary emergency measures** in case of sickness or accident of your child. **All expenses incurred will be at your expense.**
- For any breach of safety instructions by the participants, the ESF will decline all responsibilities in the event of an accident.
- It is imperative that your child is covered by a civil liability
